- 1. Read 2/10 Minutes
 - a. Made Adjustments to accurately reflect the meeting.
 - i. Unanimously Approved Minutes.
- 2. Preparing for Church Status Application
 - a. Lyn has been reminded that the Gathering Room Policy and Speaker's Policy need to be done or at least re-drafted by April 14th.
- 3. Scholarship Policy
 - a. Tom has been asked to write a Scholarship Policy and take a break on the Leadership and Governance Policy.
 - i. The Board of Directors decided the following:
 - 1. At least 5% Of Top Line revenue is to be allocated to scholarships.
 - ii. The board of Trustees decided on the following:
 - 1. Only Members are to receive scholarships as it is a member benefit.
 - 2. A member may only receive one EVENT scholarship every Two years.
 - 3. A member may only receive two BOOK scholarships each year.
 - 4. Book scholarships are to be on a first come, first serve basis.
 - 5. After a recipient is notified a proof of plane ticket or itinerary is required from the participant unless they live in the area of the event which they have been awarded a scholarship.
 - 6. Future budgets will be required to have a set number of scholarships awarded per event, and allowing additional scholarships to be awarded if the event revenue is allowing.
 - b. The Trustee board has decided that forming a Scholarship Committee is necessary. The following details have been discerned:

- i. The budget is set, but the Scholarship Committee will decide the disbursement of budgeted money.
- ii. The Scholarship Committee will receive Scholarship requests and decide on recipients.
- iii. Applicants should be notified at least 8 weeks prior to an event to know if they received the scholarship or not.
- iv. Scholarship applications should be accepted all year long until 10 weeks prior to an event.
- 4. Nominated a Secretary for the Board of Directors and will approach the nominee.
- 5. Critical issues with BlueHost have been solved on the Safari browser and the web team will continue to resolve non-critical issues and issues in other browsers.
- 6. Neat Statistics have been given by BlueHost:
 - a. Awakening-Together has had 2,221 unique visitors who have come 4,950 times. The visitors have visited 24,434 pages, and Awakening-Together has shown up over 105,000 times in searches this month. The largest hits on a page were on February 9th with 11,218 hits.
- 7. Proposed an Agenda item to discuss who decides what events Awakening-Together offers.
