- 1. Approve 3/2 Minutes
 - a. No revisions to the minutes were suggested in email, therefore, the minutes were unanimously approved during the meeting without change.
- 2. Centering Quote
 - a. The Trustees centered with a quote from Luke of the New Testaments and briefly shared their contemplation.
 - b. Jay agreed to select the next quote by April 2nd, 2015.
- 3. Mooji Retreat Proposal
 - a. The proposal committee met with Norma and agreed that Trails End in Pennsylvania was the top choice. Regina will be going to see the retreat center at the end of April, and Norma may join her.
 - b. Regina will be contacting Mooji's representative during the first week of April.
 - c. An idea was offered suggesting Awakening-Together charter airplane services. No discussion took place regarding the possibility.
- 4. James Twyman event in Colorado

a. Lyn spoke to James Twyman and confirmed that he was interested in some kind of event in Colorado. Next, Lyn contacted the Rocky Mountain Miracle Center, Mile High Church, and Lyn Corona, without receiving a response. She will continue contacting facilities and will provide information about dates and prices when a facility is found.

5. Next MPP Start-Up.

- a. The next MPP begins in April, 2015 and will be co-taught by Nyki and Jacquelyn.
 - i. The Introduction to MPP is scheduled for Saturday, April 4th from 10am-12pm ET.
 - ii. The first True Discernment class is scheduled for Saturday April 18th with the meeting time still pending. The True Discernment class will end on June 27th.

6. New Online Church Platform Update

- a. The Online Church Platform committee is running many of the new platforms previously discussed. Some technical issues are being addressed, such as how to connect a platform to the Awakening-Together radio without Pal-talk.
- b. The trustee meetings in April may be held in some of these new platforms instead of Google Hangout so that trustees may participate in testing the software.

7. Northern Ireland Retreat and Loreto, Mexico pilgrimage

- a. Regina was invited to a retreat in Northern Ireland at the end of August. Awakening-Together members are invited to come; some marketing information about the retreat will be posted soon.
- b. Regina proposed a pilgrimage in Loreto, Mexico. After visiting the place herself she likened its atmosphere to Mount Arunachala, found a place to walk, and a hotel that many could stay at.
 - i. Regina asked the trustees to contemplate the idea of having a pilgrimage retreat over the next few weeks and come to the next meeting ready to discuss the idea further.
 - ii. The ideal time frame for the pilgrimage is around March or April of 2016.

8. Change of Member Meeting Dates Update

a. Regina proposed that we change the Member Meeting in September from the first Sunday of the month to the second Sunday of the month due to holiday. The proposal was unanimously approved in order to avoid a conflict with labor day.

9. Fall Retreat Update

a. No new news.

10. Merchandise Update

a. Five shirts (12%) of the forty ordered shirts have been sold.

11. Marketing Materials for Conferences Update

a. An online company named PSPrint was found to print the Awakening-Together brochures. The Trustees, on the president minister's authority, agreed to order 500 brochures for about \$222. The brochures were sent out for final proof reading and the order was placed before the end of the evening.

12. Fundraising and Grant Committee Update

a. The Fundraising and Grant committee reported a \$12,300 total in the Retreat Center fund.

13. Forum Implementation

a. With the first set of graduating ministers being ordained in May, Regina proposed that the forum software be used to start the Minister's Association. No discussion took place on this idea. Meeting Adjourned at [6:53]MT
