Memorandum of Understanding

Between

The College of the Marshall Islands and the Kili Bikini Ejit Local Government

This Memorandum of Understanding (hereinafter referred to as MOU) between the College of the Marshall Islands (hereinafter referred to as CMI), and the Kili, Bikini, Ejit Local Government (hereinafter referred to as KBE).

WHEREAS CMI seeks to expand the educational and vocational programs to communities to meet the growing demand from Local Governments and the RMI Government;

WHEREAS, CMI has the resources to provide the Adult Basic Education and other Vocational Training in the Kili Community.

WHEREAS, KBE Local Government intends to assist the youths to acquire a high school diploma and prepare them for gainful employment and/or transition to post-secondary career and technical education

AGREEMENT

NOW, THEREFORE, CMI and KBE agree as follows:

Terms and Conditions:

A. KBE agrees it will:

1. Select at least 15 participants in agreement with CMI for the Adult Basic Education program
2. Organize and identify classroom space for the program
3. Contribute to the general expenditure of the programs conducted for the KBE youths
4. Maintain records of the participants and their regular participation, and report to CMI ACE office.
5. Provide the students with the necessary instructional supplies needed for the program
6. Provide accommodation for visiting CMI staff.

B. CMI agrees to:

1. Provide the ABE program to the students in the Community.
2. Ensure that the program is carried effectively and efficiently.
3. Train the Adjunct Faculty who will coordinate the program
4. Provide regular updates of the students progress to the KBE Local Government office
5. Compensate the Adjunct Faculty who will instruct the students
6. Develop vocational programs suitable for the community in consultation with the Local Government office

Effective Date.

1. This MOU is effective upon signing by the President of CMI and the authorized signatory of the KBE Local Government.
2. This MOU shall remain in effect until either party provides the other with a minimum of two weeks' written notice of intent to terminate this contract.

3. The MOU may be modified by an addendum with the written consent of both parties.

CMI will not be held responsible for damage to the classrooms or furniture in case of accidents, fire, burglary and other forms of disaster.

IN WITNESS THEREFORE, the parties have executed the Agreement of the date first written.
