



# Memorandum of Understanding between the College of the Marshall Islands and the Public School System

This Memorandum of Understanding (hereinafter referred to as MOU) between the College of the Marshall Islands (hereinafter referred to as CMI), and the Public School System (hereinafter referred to as PSS) provide for the establishment of the College of the Marshall Islands Wotje Center (hereinafter referred to as the Center).

WHEREAS CMI seeks to expand its educational programs to Wotje to meet the growing demand from the Public School System and the RMI Government.

WHEREAS, CMI has the resources to provide quality educational services to the Wotje community.

## **AGREEMENT**

## **Terms and Conditions**

NOW, THEREFORE, CMI and PSS agree as follows:

# A. PSS agrees it will provide CMI:

1. with exclusive access to the Japanese bunker at the entrance to Northern Islands High School (NIHS) and surrounding areas as stipulated in the building designs for the construction of staff housing and restroom facilities for the sole purpose of meeting the College's mission to provide quality and student-centered learning and learning support services.

# B. CMI agrees to:

- 1. Be responsible thereafter for the general maintenance of the buildings and facilities constructed by CMI for the delivery of CMI programs and activities.
- 2. Be responsible for additional equipment and furniture needed at the Center.
- 3. CMI will work with the National Telecommunications Authority (hereinafter referred to as NTA) to connect the Center to the internet and assumes the costs thereof for the most reliable and convenient internet connection subscription for the Center.
- 4. Allow NIHS students, supervised access to the CMI computer lab facilities at prearranged times on a schedule that is negotiated and approved by the







employees access to the same computer facilities.

- 5. Be responsible for replacing and/or installing air conditioners and lights at the Center as CMI sees necessary. CMI will also be responsible for paying the Center's monthly utility costs.
- 6. Manage its employees at the Center according to CMI's policies and procedures.

#### **Amendments**

The MOU may be modified by an addendum with the written consent of both parties.

## **Duration and termination**

**Effective Date:** This MOU is effective upon signing by the President of CMI and the authorized signatories of the PSS and shall remain in effect until either party provides the other with at least two months' written notice of intent to terminate with the termination occurring at the end of CMI's current semester at the time of the issuance of notice. All equipment, furniture, property and other incidentals purchased by CMI shall be retained by CMI.

IN WITNESS THEREFORE, the parties have executed the Agreement on the dates as stated below.
