- 1 2. Debtors will cure the current plan payment arrears of \$1,149.34 within six months of the
2 date of this order.
- 3 3. If Debtors fail to comply with the terms of this Order, the Trustee will mail to the
4 Debtors and to the Debtors' attorney a notice of failure to comply, identifying the default
5 under the terms of this order. Should the Debtors fail to remedy the default identified in
6 the notice within ten (10) days of the mailing date of such notice, the Trustee may
7 submit an *ex parte* order of dismissal to the Court and the Court may dismiss this case
8 without further notice or hearing.
- 9 4. The Trustee is required to send notice of default to the Debtors, as noted above, no more
10 than one time. Upon the second default under the terms of this order, the Trustee may
11 submit an *ex parte* order of dismissal to the Court and the Court may dismiss this case
12 without further notice or hearing;
- 13 5. This Strict Compliance order resolves the Trustee's Motion to Dismiss originally set for
14 hearing on March 12, 2019.
